The below proposal was approved by ICSF Board on its meeting 3.7.2024. The mentioned change is now implemented into the

FAO: ICSF Board **Subject:** Fly casting rule change ev .no1 and 2

After careful research and an accurate evaluation, the Fly Casting Technical Commission deems it absolutely necessary to make a change to the ICSF FLY CASTING rules currently in force relating to EVENT nr 1 and EVENT nr 2.

This modification was necessary because the SCIENTIFIC ANGLERS company that producing the fly line adopted for events nr 1 and nr. 2 named "MASTERY EXPERT DISTANCE ORANGE WF5F" is not able to provide fly lines of the "exact" length specified in the current rule as (120' 36.60 m).

Having established this, the only solution is to adopt a minimum length of 35.50 m; TO AVOID DISQUALIFICATION .

In addition, again for reasons related to uniformity and related performance, the possibility (not the obligation) of eliminating BOTH connection LOOPS in event nr 2; and the front taper LOOP in event nr 1.

The change was necessary to make the athletes' equipment uniform in the best possible way; always in the spirit of healthy sporting competition.

Therefore we suggest following rule changes (RED will be erased, GREEN will be added)

Event 1 Trout Accuracy

Current wording .. Line: Scientific Anglers Mastery Expert Distance Competition WF5F (orange, 120 ft). The line is not to be modified in any way, except from cutting the loops in front and not in the back. The line must be laser marked from producer. The line must not be marked in any way to indicate distance.

New wording : Line: Scientific Anglers Mastery Expert Distance Competition WF5F, The line is not to be modified in any way, except from cutting the loop in front and not in the back. The line must be laser marked from producer. The line must not be marked in any way to indicate distance.

Event 2 Trout Distance

Current wording ... Line: Scientific Anglers mastery expert distance competition WF5F (orange, 120 ft.). The line is not to be modified in any way, except from cutting the loops in front, not in the back. The line must be laser marked by the producer. It is not allowed to mark the line in any way

New wording : Line: Scientific Anglers mastery expert distance competition WF5F, minimum length admitted 35,50 mt. The line is not to be modified in any way, except from cutting the loops in front and in the back. The line must be laser marked by the producer. It is not allowed to mark the line in any way to indicate distance.

We ask the Board to approve and implement the new rule updates asap!
